Sub: Public Services – Promotion and Posting of Multi Tasking Staff
(General) as Lower Division Clerks – Orders – Issued.


The Multi Talking Staff (General) mentioned in the Annexure to this Memorandum are promoted as Lower Division Clerks on ad-hoc basis and posted in the Departments / Offices noted against them with immediate effect.

They are directed to report for duty on or before **28/04/2017**, failing which it will be presumed that he/she has declined the promotion offered and he/she will not be considered for promotion for a period of one year or next DPC, whichever is later, from the date of issue of the promotion order.

5. The Heads of Department/Offices concerned are requested to relieve the officials without waiting for substitute and request for retention / modification of promotion orders will not be entertained.
