

4. They shall report for duty on or before **19/10/2018**, failing which it will be presumed that he/she has declined the promotion offered and he/she will not be considered for promotion for a period of one year or next DPC, whichever is later, from the date of issue of the promotion order.

5. The Heads of Department/Offices concerned are requested to relieve the officials without waiting for substitute and request for retention / modification of promotion orders will not be entertained.
