**ORDER:**

In exercise of the powers conferred by Part-III and Part-IV of the Schedule to the Central Civil Services (Classification, Control and Appeal) Rules, 1965, the Lieutenant Governor, Puducherry specified the Appointing Authority, Disciplinary Authority and Appellate Authority in respect of Group 'C' and Group 'D' posts vide G.O. first read above.


2. Consequent to the implementation of Central Civil Services (Revised Pay) Rules, 2008, even certain erstwhile Group 'C' posts now stand classified as Group 'B' as per the G.O. second read above and accordingly, the Lieutenant Governor shall become the Disciplinary Authority for those posts also as they are in Group 'B' now.

3. Whereas, as specified in Part-II – Central Civil Services, Group 'B' of the Schedule to the Central Civil Services (Classification, Control and Appeal) Rules, 1965, Administrator / Head of the Department shall be the Authority competent to impose all penalties under Rule 11 in terms of Rule 2 of the above Rules. As such and in partial modification of the orders in the G.O. first cited and as per Rule 2 read with Part-II of the Schedule of the Central Civil Services (Classification, Control and Appeal) Rules, 1965, the Lieutenant Governor, Puducherry is pleased to specify that the Secretaries to Government in this Administration shall henceforth be the Head of the Department for the purpose of exercising the powers and function as Disciplinary Authority in respect of Group 'B' posts carrying the Grade Pay upto ₹ 4,600/-, so as to impose all the penalties in terms of Rule 11 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965.

4. The Appellate Authority shall be the President of India in respect of all Group 'B' and Group 'A' posts.

5. The disciplinary cases which have already been commenced prior to the issue of G.O. second read above wherein the revised classification of posts has been communicated as per VI CPC recommendations, may, however, be continued and disposed by the respective Disciplinary Authorities and Appellate Authorities as specified in the G.O. first cited.
