

 4. Community Certificate (obtained in the prescribed form issued by an officer of the Department of Revenue and Disaster Management not below the rank of Deputy Tahsildar. The certificate should have been issued within one year from the date of notification of results of this recruitment test);
 5. Certificate issued by the District Medical Board, Puducherry/Karaikal in case of Differently-Abled (PH) Persons.
2. No T.A will be paid for the certificate verification.
3. In-service candidates should obtain the service certificate from the Head of Department / Office indicating his/her Name/Designation/Education Qualification/ Date of Initial Appointment with name of post/category to which he/she belongs to etc., in support of his/her claim.
4. If he/she failed to appear for certificate verification on the date and time prescribed above, his/her provisional selection will be treated as cancelled.




