
WHEREAS the Government of Puducherry, Department of Personnel & Administrative Reforms (PW), vide G.O. 1st cited have created 160 posts of Record Clerk/Keeper carrying the scale of pay of ₹5,200-20,200 + Grade Pay of ₹1900/- [₹3050-4590 (pre-revised)] in various Government Departments/Offices of this Administration;

AND WHEREAS vide this Department's G.O. 2nd cited necessary Recruitment Rules for the posts of Record Clerk/Keeper have been notified;

AND WHEREAS vide this Department's Memoranda third to thirteen cited, 160 MTS were promoted as Record Clerk/Keeper. In para 3 of the said Memoranda cited, the condition for declaring probation i.e. the promotees should have to pass the Accounts Test for Subordinate Officers: (Part-I & Part-II) within the period of probation has been inadvertently mentioned even though there is no such stipulation available in the Recruitment Rules for the said post;

NOW THEREFORE, the said condition indicated in para 3 of the Memoranda cited stand deleted.
