
The officials mentioned in the **Annexure** were promoted to the post of Superintendent on ad-hoc basis, vide Memo. dated 07.08.2013. However, due to the orders of Hon'ble Supreme Court of India to maintain "status quo" on 08.08.2013 in the SLP(C) Nos. 25025 & 25026 of 2013, filed by the Puducherry Executive & Technical Officers Association, Puducherry, they could not join the promotional post of Superintendent.

2. Consequent to the out-of-court settlement reached between the Government of Puducherry and the Puducherry Executive & Technical Officers Association, Puducherry and Puducherry Stenographers Welfare Association, Puducherry the SLP (Civil) Nos. 25025 & 25026/2013 and SLP (Civil) Nos. 34171 & 35570/2013 filed by the said Associations challenging the amalgamation of the posts of Superintendent Gr-II and Gr-I as Superintendent w.e.f. 01.01.1996 vide G.O.Ms.No.106, dated 07.01.2006 of DP&AR(PW), Puducherry, have been disposed by the Hon'ble Supreme Court of India vide Order dated 09.01.2015.

3. Subsequently, promotion to the post of Superintendent on ad-hoc basis was again offered to the nine Assistants out of eleven Assistants (mentioned in the Annexure), who were in service by then, vide Memo. dated 19.01.2015.

4. Accordingly, as per the approval accorded by the Lieutenant Governor, Puducherry the officials detailed in the **Annexure** are promoted to the post of Superintendent on ad-hoc basis with notional effect from the date noted against them i.e. the date of joining of his/her junior and with monetary benefit from the date of actual joining in the post of Superintendent.
