ORDER

Sub: Public Services - Grant of notional promotion to the Superintendent - Orders - Issued.

Consequent to the out-of-court settlement reached between the Government of Puducherry and the Puducherry Executive & Technical Officers Association, Puducherry and Puducherry Stenographers Welfare Association, Puducherry the SLP (Civil) Nos. 25025 & 25026/2013 and SLP (Civil) Nos. 34171 & 35570/2013 filed by the said Associations challenging the amalgamation of the posts of Superintendent Gr-II and Gr-I as Superintendent w.e.f. 01.01.1996 vide G.O.Ms.No.106, dated 07.01.2006 of DP&AR(PW), Puducherry, have been disposed by the Hon'ble Supreme Court of India vide order dated 09.01.2015, as follows:

"We dispose these petitions in terms of the settlement arrived at between the parties and terms and conditions of the settlement shall form part and parcel of this order".

2. Among other things in the terms of agreement, it has been agreed by the Government that Stenographer Gr-II (now re-designated as Stenographer Gr-I) who are fully eligible for promotion in all respects, viz. residency period and passing of Account Test (Higher) to the erstwhile post of Superintendent Gr-II, on the date of amalgamation i.e., on 07.01.2006 will be notionally promoted as Superintendent with effect from the date of promotion of the Assistant to the post of Superintendent made in the year 2010 and subsequently in the year 2013, according to their inter-se-seniority subject to availability of vacancies and their fulfillment of residency period for promotion from the Grade pay of Rs.4200 to Rs.4600.

3. It is pointed out that as per the agreement, this Department promoted 31 Stenographers Gr-I (Erstwhile Stenographer Gr-II) as Superintendent on ad-hoc basis vide Memo. dated 24.03.2015 with prospective effect, vide reference cited after obtaining approval of the Competent Authority viz. the Lieutenant Governor, Puducherry.



4. Subsequently, in consonance with the terms and conditions of the agreement, 24 Superintendents (out of 31 Superintendents promoted from Stenographer Gr-I) were notionally promoted on ad-hoc basis on par with the 86 Assistants promoted on ad-hoc basis during the year 2010, vide Order dated 23.12.2015.

5. Now the remaining seven Superintendents (31-24 Superintendents promoted from Stenographer Gr-I) are to be considered for notional promotion on par with the 151 Assistants promoted on ad-hoc basis during the year 2013, vide Memo. dated 07.08.2013.

6. Accordingly, as per the approval accorded by the Lieutenant Governor, Puducherry the officials detailed in the **Annexure** are promoted to the post of Superintendent on ad-hoc basis with notional effect from the date noted against them i.e. the date of joining of his/her junior according to the inter-se seniority and with monetary benefit from the date of actual joining in the post of Superintendent.
