4. The candidates are directed to report for duty on or before 13-02-2015, failing which it will be presumed that he has declined the promotion offered and he will not be considered for promotion for a period of one year or next DPC, whichever is later, from the date of issue of this order.
5. They are to be relieved immediately without waiting for substitute. In case, any of the promotee is declining his promotion as Driver (LMV) Grade-III, the same may be reported to this Department on or before 13-02-2015 without fail. Request for change of place of posting will not be entertained.
6. In case, any disciplinary proceedings are pending/contemplated against any of the candidates, the promotion orders may not be served to them and the fact may be intimated to this Department. .


