In respect of posts of Chairman/ Managing Director of Public Sector Company/ Society/ Organization, the link Secretary shall not discharge the functions of such Chairman/ Managing Director, since they are statutory in nature, except where the appointment is by designation. Where the appointment is by name, specific orders of Lieutenant Governor shall be obtained to hold the charge.
- 3. In case of absence of both the Secretary and his link Secretary on account of tour, leave, transfer, etc., the link officer to that particular link Secretary shall look after the duties of the Secretary concerned.
- 4. The Lieutenant Governor is further pleased to order that, if for any reason, the above said link arrangements cannot be operated, the Chief Secretary shall allot the work to any other Secretaries / Special Secretaries as required.
