Applications are invited from eligible and suitable officers for filling the post of Director General, National Institute of Plant Health Management(NIPHM), Hyderabad in the Pay Band-4(Rs.37,400-67,000 plus Grade pay Rs.10,000/- on deputation basis. NIPHM, Hyderabad is an autonomous body registered under the Andhra Pradesh Societies Registration Act.,2001 under the jurisdiction of Ministry of Agriculture(Department of Agriculture and Cooperation). This institute imparts training in human resource development in plant protection technology. Besides, meeting the emerging training needs this institute functions as a centre of excellence and policy support centre in the matters of bilateral/multilateral negotiations on Sanitary and Phytosanitary(SPS) matters, plant protection activities and providing training capability to private sector and farmers. Details of the post, eligibility conditions etc. are given in the Annexure-I. The pay of the officer selected for appointment on deputation basis will be regulated in terms of DOPT's O.M. No. 2/29/91-Estt.(Pay.II), dated 5.1.1994 and subsequent orders issued from time to time.

Applications of only such officers will be considered which are routed through proper channel and are accompanied with (i) Bio-data(in duplicate) as in the proforma given(Annexure-II) (ii) Attested photocopies of APARs for the last five years(APARs to be attested by an officer not below the rank of Under Secretary)(iii)Vigilance clearance/Integrity Certificate and (iv) Statement giving details of major or minor penalties imposed on the officer, if any, during the last 10 years(Annexure-III).




