MEMORANDUM

Sub: Public Services – Revised Tentative seniority list of
Superintendent Gr.I – Circulated.

3. O.M.No.20011/1/2001-Estt(D), dated 21.1.2002 of Ministry of Personnel, P.G. and Pensions, Dept. of Personnel & Training, New Delhi communicated vide G.O.Ms.No.15, dated 5.3.2002 of DP&AR, Puducherry.

The final seniority of Superintendent Gr.I who were appointed upto 1997 was fixed in this Dept.'s G.O. under reference second cited as per the guidelines issued by the Govt. of India in O.M. dated 30.1.1997 under reference first cited according to which if a candidate belonging to SC or ST is promoted to an immediate higher post/ grade against a reserved vacancy earlier than his senior General/ OBC candidate, who is promoted later to the said immediate higher post/grade, the General/OBC candidate will regain his seniority over such earlier promoted candidate of the SC and ST in the immediate higher post/grade.

2. Thereafter the position emerged in view of the guidelines issued in the above referred O.M. dated 30.1.1997 has been reviewed in view of the judgement of the Supreme Court dated 10.10.1995(in the case of Union of India Vs Virpal Singh Chauhan) and the Govt. of India have decided to negate the effects of the said O.M.No.20011/1/96-Estt(D) dated 30.1.1997 of Dept. of Personnel & Training by amending Article 16(4A) of the Constitution of India, right from the date of its inclusion in the constitution i.e. 17.6.1995 and communicated revised orders vide O.M.No.20011/1/96-Estt(D) dated 21.1.2002 of Dept. of Personnel & Training, New Delhi under reference third cited with a view to allow the Government servants belonging to SC/ST to retain the seniority in the case of promotion by virtue of rule of reservation and accordingly the candidates belonging to General/ OBC

category promoted later will be placed junior to the SC/ST Government servants promoted earlier even though by virtue of the rule of reservation. In pursuance of the above revised guidelines of Govt. of India, the final seniority of Superintendent Gr.I fixed earlier in G.O. second cited has been revised and the revised final seniority list of Superintendent Gr.I was issued vide G.O. under reference fourth cited to allow the Government Servants belonging to SCs/STs to retain their seniority in the case of promotion by virtue of rule of reservation.

3. Aggrieved to the above referred revised final seniority of the Superintendent Gr.I, Thiru S. Alphonse, presently functioning as the Under Secretary to Govt.(Works) in this Administration has filed an O.A. No.435/2003 in the C.A.T., Madras Bench, Madras. The Hon'ble C.A.T. in its order dated 12.6.2009 in the above O.A. has observed that the benefit of consequential seniority is available only to those employees who are promoted after 17.6.1995 and those who were promoted prior to 17.6.1995 will not be entitled for consequential seniority. Therefore directed the respondent Government to revise the seniority of those who were promoted prior to 17.6.1995 as those respondents who were promoted after 17.6.1995 alone can retain consequential their seniority.

4. Now, in consideration of the above orders of the Hon'ble C.A.T., Madras, it has been decided by the Government to revise the revised final seniority list of Superintendent Gr.I fixed earlier in the G.O. fourth cited. Therefore, it has become necessary to circulate a revised tentative (Final) seniority list of Superintendent Gr.I as indicated in the "Annexure" to the Memorandum.

5. Objections, if any, to the seniority as assigned in the Annexure may be made to this Department on or before 10.9.2010. If no objection is received by the date, it will be presumed that the officers concerned have nothing to represent and this Department will proceed to fix the revised final seniority accordingly. In case any of the officers listed in the Annexure is working in some other Department the tentative seniority list may be sent to that Department.
