2. This Department's Memorandum No.A.23017/1/2013-DP&AR/SS.II(1) dated 12.07.2013



In continuation of final seniority list of Assistants notified in the G.O. cited, the tentative seniority of 145 Assistants who have been appointed subsequently has been circulated vide Memorandum cited calling for objections, if any, to the seniority assigned on or before 31.07.2013.

2. It is found that some of the Assistants who are seniors in the grade of UDC but regularized subsequently and some of the Assistants who were offered notional promotion by review DPCs were inadvertently left out. Their names are now included as indicated in the Annexure to this Memorandum in the respective places of the Tentative seniority list issued vide reference 2<sup>nd</sup> cited considering their relative seniority in the feeder grade of UDC.

3. It is therefore decided to circulate this modified tentative seniority list alongwith the tentative seniority list already issued under reference. Objections, if any, to the seniority assigned may be made to this Department on or before 30.08.2013.

4. If no objections are received by that date, it will be presumed that the Assistants have nothing to represent, the Department will proceed to fix their seniority accordingly. If there is any change in their present designation or in the department against which they are shown as working, the same may also be intimated to this Department.


